This memo is to update you on the status of the Huscroft Educational Trust. In January of this year, there were two new applications for Fall 2007 awards. And there were several applications for renewals both for Spring 2007 and Fall 2007.

Spring 2007 awards were promised to previous recipients to support their ongoing studies as follows:

These awards will generally be paid in two installments, the first in March 2007 and the second in September 2007, except for the award to Core Duce, which will be paid in March 2007. The Advisory Board of the Huscroft Educational Trust recommended these awards based on the criteria set out in the trust document:

1. Economic potential of the trade or profession chosen and degree, diploma or certificate sought
2. Financial need of the applicant
3. Academic achievement or trade skill of the applicant
4. Cost and location of the educational institution relative to other equivalent educational options
5. Age of applicant; with priority being given to youth
6. Equity amongst beneficiary groups within the Huscroft Family

In addition to these new awards, previously committed awards will be paid in March 2007 to Lara Litchfield, Patricia Facuri, Sarah Hummel, Fabricius Martins, Jordan Litchfield, and Colten Huscroft. Total payments by the Huscroft Educational Trust in March 2007 will be \$22,250. Payments are made upon timely receipt of proof of admittance or transcripts as outlined in the award letters. By the end of March 2007, the Huscroft Educational Trust will have paid a total of \$268,425 to students as follows:

The next awards will be for Fall 2007. It is anticipated that \$70,000 (Canadian) per year will be awarded through distributions of small (\$1,000) to large (\$10,000) annual awards. Awards may be given for multiple years, but must be renewed each year. Applications for Fall 2007 must be received by July 15<sup>th</sup>, 2007 to be considered. Note that Applications can now be made just 3 months prior to the first payment date, instead of 9 months prior to the first payment date as was done in years past. Applications should be sent to the chair at the address, fax or email given below. Use of email or fax is preferred in order to ensure that documents arrive before the deadline. Emailed documents must be sent as PDF files, WORD documents, or JPEG images. Documents that are sent by regular mail should also be sent by fax. The application forms are available on line at [www.huscroft.ca](http://www.huscroft.ca) where the new application procedures are explained in detail.

The responsibility of making award recommendations is the role of the Advisory Board. I would like to thank John Huscroft, Dot Rathgeber, Dawn Sommerfeld, and Marilena Facuri for their past service on the Advisory Board. The new Advisory Board members are Patricia Huscroft, Alicia Huscroft, Scott Dempster, Peter Dempster and Vanessa Mair. If you have any questions, please contact one of the Advisory Board members.
