This memo is to update you on the status of the Huscroft Educational Trust. In January of this year, there were two new applications for Fall 2008 awards. And there were several applications for renewals both for Spring 2008 and Fall 2008.

Spring 2008 awards were promised to previous recipients to support their ongoing studies as follows:

These awards will generally be paid in two installments, except for the award to Marden Litchfield, which will be paid in March 2008. Spring 2008 awards are paid in March 2008 and September 2008 whereas Fall 2008 awards are paid in September 2008 and March 2009. The Advisory Board of the Huscroft Educational Trust recommended these awards based on the criteria set out in the trust document:

1. Economic potential of the trade or profession chosen and degree, diploma or certificate sought
2. Financial need of the applicant
3. Academic achievement or trade skill of the applicant
4. Cost and location of the educational institution relative to other equivalent educational options
5. Age of applicant; with priority being given to youth
6. Equity amongst beneficiary groups within the Huscroft Family

In addition to these new awards, previously committed awards will be paid in March 2008 to Patricia Facuri, Sarah Hummel, Fabricius Martins, Jordan Litchfield, Colten Huscroft, Brittany Corwin, Jordan Huscroft, Ryan Hiebert and Melanie Riddell. Total payments by the Huscroft Educational Trust in March 2008 will be \$30,100. Payments are made upon timely receipt of a payment request containing proof of admittance or transcripts as outlined in the award letters. By the end of March 2008, the Huscroft Educational Trust will have paid a total of \$329,675 to students as follows:

It is with great pleasure that we can report that Alexandre Chareti and Lara Litchfield have graduated from their programs. The next awards will be for Fall 2008 and Spring 2009. It is anticipated that \$70,000 (Canadian) per year will be awarded through distributions of small (\$1,000) to large (\$10,000) annual awards. Awards may be given for multiple years, but must be renewed each year. Applications for Fall 2008 must be received by July 15th, 2008 to be considered. Note that applications can be made just 3 months prior to the first payment date, instead of 9 months prior to the first payment date, as was done in years past. Thus applications for Spring 2009 can be submitted by July 15, 2008 or January 15, 2009. Early applications will typically receive preference. Applications should be sent to the chair at the address, fax or email given below. Use of email or fax is preferred in order to ensure that documents arrive before the deadline. Emailed documents must be sent as PDF files. Documents that are sent by regular mail should also be sent by fax. The application forms are available on line at www.huscroft.ca where the application procedures are explained in detail.

The responsibility of making award recommendations is the role of the Advisory Board. The Advisory Board members are Patricia Huscroft, Alicia Huscroft, Scott Dempster, Peter Dempster and Vanessa Mair. If you have any questions, please contact one of the Advisory Board members. Their contact information will be available on line at www.huscroft.ca. Over the coming months I will look forward to receiving applications for Fall 2008 and Spring 2009 awards.
